## Yukon ACOL Personal Property Registry System Now Live!

As of today, Monday, June 27, 2016, the migration of the Yukon Personal Property Security Registry to the ACOL Personal Property Registry (PPR) System is complete. All transactions related to registering, amending, discharging or searching personal property registrations in Yukon are now conducted through Yukon ACOL PPR.

### Legislative Changes

Following the proclamation on May 4, 2016, the *Personal Property Security Registry (Electronic) Amendments Act* and new regulations have now come into full force as of June 27, 2016.

### ACOL account now required for use

If you have not yet established a client account with ACOL, you will need to do so in order to gain access to the Yukon registry and any other ACOL PPR jurisdictions you choose.

If you need work done immediately, you can pay a [value-added service provider](#) to access the PPR for you.

You will find the application forms, financial agreement forms, instructions and other information at [www.acol.ca/en/service/pprs](http://www.acol.ca/en/service/pprs).

If you already have an ACOL account, complete the [addendum form](#) to add access to Yukon. Select 'Add (or delete) access to a jurisdiction's PPR'.

**Note:** Please allow two to three weeks for your account(s) to be created and to receive your welcome package with everything you need to begin using the system. You may submit your application by email or by fax, but your user ID will be sent to you by regular mail.

### Be a Value-Added Service Provider

It's free and it's a great way to advertise your services to potential clients in Yukon and across the country.
