

Fee Schedule for Insurance

Agents

1. Fees payable by agents who reside in the Territory for licences:
 - (a) to undertake all classes of insurance other than life insurance.....\$50.00
 - (b) to undertake life and accident and sickness insurance\$100.00
 - (c) to undertake accident and sickness insurance.....\$50.00
 - (d) to undertake only Travel Accident and Sickness Insurance incidental to or as a part of the normal business of a travel agent.....\$ 5.00

2. Fees payable by agents who do not reside in the Territory or maintain an office for business purposes in the Territory and who solicit business in person in the Territory, for licenses:
 - (a) to undertake all classes of insurance other than life insurance.....\$100.00
 - (b) to undertake life and accident and sickness insurance\$200.00
 - (c) to undertake accident and sickness insurance.....\$100.00
 - (d) to undertake only Travel Accident and Sickness Insurance incidental to or as a part of the normal business of a travel agent\$ 5.00

Adjusters

3. Fees payable by adjusters for licences:
 - (a) authorizing the making of adjustments by a firm or partnership and one designated partner thereof, or by a corporation and one designated officer thereof.....\$75.00
 - (b) authorizing the making of adjustments by any additional partner, officer or employee of a firm, partnership or corporation that is the holder of a licence as an adjuster\$10.00
 - (c) in all other cases\$75.00

Fees payable by adjusters who do not reside in the Territory or maintain an office for business purposes in the Territory and who solicit business in person in the Territory:

- (a) authorizing the making of adjustments by a firm or partnership and one designated partner thereof, or by a corporation and one designated thereof \$150.00
- (b) authorizing the making of adjustments by any additional partner, officer employee of a firm, partnership or corporation that is the holder of a licence as an adjuster \$ 20.00
- (c) in all other cases \$150.00

Brokers

- 4. Fees payable by brokers who reside in the Territory for licences\$50.00
 - (a) Fees payable by brokers who reside in the Territory for business with unlicensed insurers and renewals thereof.....\$200.00
 - (b) Fees payable by brokers who do not reside in the Territory or maintain an office for business in the Territory and who solicit business in person in the Territory for licenses.....\$100.00
 - (c) Fees payable by brokers who do not reside in the Territory or maintain an office for business purposes in the Territory and who solicit business in person in the Territory with unlicensed insurers and renewals thereof.....\$400.00

Salesperson

- 5. (a) Licence fee payable by a salesperson who resides in the Territory.....\$25.00
- (b) Licence fees payable by a salesperson who does not reside in the Territory or maintain an office for business in the Territory and who solicits business in the Territory.\$50.00
- (c) Fees payable by a salesperson selling only Travel Accident and Sickness Insurance as employees of an agent licensed under 4(d) or 5(d)\$ 5.00

General

- 6. Fees payable for amending or reinstating a licence\$2.00
- 7. Fees payable by joint stock companies, incorporated by the Territory or any other province in Canada but not registered by the Dominion, for a licence for the business of plate glass insurance.....\$50.00
- 8. Fees payable for transportation companies\$50.00
- 9. Certificate of Superintendent.....\$ 5.00
- 10. Copies of an extract from documents filed with or by the Superintendent per folio of 100 words, or part thereof.....\$ 5.00
- 11. Certified Copy of licence\$ 5.00
- 12. Duplicate of licence.....\$ 2.00
- 13. Power of attorney fee.....\$10.00

Where the fee payable for any licence other than a licence for an adjuster or a broker, exceeds \$10.00 and such licence is issued after the expiration of six months of the year in respect of which the licence is issued, the amount payable in respect of such licence is on-half the payment set out in the these Regulations.
